9 Spokes appoints Adrian Grant (Co-founder) as executive director

Summary of employment

The Company has entered into an employment agreement with Adrian Grant under which Adrian is employed in the role of Head of Strategic Relationships. The agreement includes a termination notice period of 3 months. The Company may terminate Adrian's employment immediately for serious misconduct. Adrian is prohibited from competing with the Company for 3 months following termination of his employment. There are also confidentiality provisions and provisions ensuring intellectual property rights vest in the 9 Spokes Group. The agreement provides that Adrian's remuneration will comprise a gross annual salary of NZ\$350,000. The Company will review Adrian's remuneration on an annual basis.
