9 Spokes International Limited (ASX: 9SP) ("9 Spokes" or the "Company") has today issued 33,333,334 fully paid ordinary shares ("Shares") at an issue price of A\$0.015 per share following approval of shareholders at a Special Meeting on Wednesday, 26 February 2020.

This issue is the second and final tranche of shares issued following the successful placement of A\$4 million announced to the market on 28 January 2020.
