## **Cleansing Notice**

### **Notice under section 708A(5) of the Corporations Act 2001 (Cth)**

9 Spokes International Limited (ASX: 9SP) (“9 Spokes” or the “Company”) has today issued 33,333,334 fully paid ordinary shares (“Shares”) at an issue price of A\$0.015 per share following approval of shareholders at a Special Meeting on Wednesday, 26 February 2020.

This issue is the second and final tranche of shares issued following the successful placement of A\$4 million announced to the market on 28 January 2020.

This notice is being given under section 708A(5) of the Corporations Act 2001 (Cth) (“Corporations Act”).

For the purpose of section 708A(6) of the Corporations Act, 9 Spokes advises that:

- (a) The Shares were issued by 9 Spokes without disclosure to investors under Part 6D.2 of the Corporations Act.
